PART I. General Expectations

Bivins Elementary agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required campus Title I Parent Engagement Plan meet the requirements of section 1118(b) of the ESEA, and include as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

- D. that parents are equal partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and

E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

PART II. Description of how **Bivins Elementary** will implement the required components of the campus Title I Parent Engagement Plan.

1. **Bivins Elementary** will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - Bivins has a Site Based Decision Making Team consisting of teachers, administrators, parents and community members that meet and develop the Parent Engagement Plan. Input used to develop the plan is gathered from data from the state, district and school as well as surveys from the parents. Surveys were printed in Spanish and English to meet the needs of parents.

2. Bivins Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - A parent meeting (Back to School Night – Open House) is scheduled in the fall to inform parents of Title I requirements and programs, parent conferences, home-school compact, grade level expectations and parent involvement activities.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - The staff has been trained in ways to effectively communicate with parents. Communications with parents will include monthly newsletters, parent conferences, home visits, phone contacts, written communications, and e-mails. Academic progress will be communicated every three (3) weeks by Progress Reports or Report Cards.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Bivins Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Communications with parents will include monthly newsletters, parent conferences, home visits, phone contacts, written communications, and e-mails. Academic progress will be communicated every three (3) weeks by Progress Reports or Report Cards.

4. Bivins Elementary will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- Bivins uses the AISD Year-at-a-Glance that is TEK based. Bivins also uses benchmark tests, six weeks test, simulations, grades, and the STAAR test to measure student growth.

5. Bivins Elementary will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- PI meetings that are in conjunction with the PTA meetings and parent meetings.

6. Bivins Elementary will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Sending home graded papers and posting the grades in Skyward, six weeks progress reports, and report cards.

7. Bivins Elementary will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey.

8. Bivins Elementary will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Library Night/Literacy Night.
- Math Night.
- Science Night.
- Discovery Center Night.
- Skyward Parent Training.

9. Bivins Elementary will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with

parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- During staff PLC and staff development have specific training on parent engagement. Bivins will also have a teacher representative during PTA meetings.

10. Bivins Elementary will, to the extent feasible and appropriate, coordinate and integrate Title I parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- New parent orientation along with a newsletter that gives helpful hints on how to help their student during their first years of school.

11. Bivins Elementary will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Interpreter and translation services will be provided at meetings where a reasonable number of parents speak a language other than English through the use of ELSA.

PART III. Discretionary Components of the Bivins Elementary Title I Parent Engagement Plan

Bivins Elementary may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:

- Involving parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
